6.b Pool Update

None

Reesa Rice, Pool Director presented an update to the board noting public swim has officially ended for the 2022 season and provided an update on the boiler failure and gave details about the boiler located at the pool. Mrs. Rice reviewed the boiler diagnosis attached in the agenda provided by RF MacDonald Company. Discussion occurred about options in replacement of boiler for a heating source including solar heating options.

President Herrera asked for staff to look into solar and price that out for a future agenda item.

Lily (member of the public) notated the Orland Pool uses solar in some capacity and some panels serve as shade structures which is something the local pool desperately needs. Discussion occurred about shade structures and shade structure support panels.

Boardmember Riggs asked about heat exchange and inquired about potential chemical concerns with geothermal and the amount of iron in our water in respect to potential future damage. Mrs. Rice provided information about the system and that she did not have a chemical concern. Executive Officer Godman provided information about the heat exchange for the board.

Bob Godman, Executive Officer presented the Lassen High School Swim Team Contract to the Board.

Vice President Gallagher inquired about the one year term, and Mr. Godman notated that due to cost and time of season and late contract negotiations, it was concluded to operate under previous contract terms and begin negotiations for modifications for the 2023 LHS Swim Team.

Mrs. Rice provided information about previous swim team season timeframes.

Board member Riggs asked how many swim team members there were. Lily (member of the public) provided information that 12 team members were on the team.

Board member Riggs asked when negotiations would occur for 2023, Mr. Godman noted that he wanted to have a renewed MOU prior to 2023 summer break.

President Herrera asked if the LHS swim team is the only users of the pool currently. Mrs. Rice noted that due to the swim team practice being held at 6:00 A.M., the pool can run additional programs such as lap swim and aqua aerobics in the morning as weather and participation allows. Mr. Herrera notated that the cost of October operations are financially straining and expressed concern. Mr. Herrera

suggested increasing programs and creative scheduling and marketing to increase patron usage to support operating in the black in fall seasons. Mrs. Rice noted that historically October has been a tough month to actively get patrons in the pool and program participants when the weather changes, school is back in session and time changes.

SUBJECT: Pool Director Update

SUMMARY: The pool's 2022 season concluded a week earlier than anticipated when it was discovered the variable speed motor that controls water circulation had abruptly stopped working. Unfortunately, the HS swim team was unable to complete their last week of practice. The HS was not billed for the first week of practice in lieu of missing the last week of practice. When an electrician was called to disconnect the power to the motor it was discovered that wiring had come loose creating an electrical shortage/fire at the point of contact. Per the electrician's recommendation all of the wiring from the motor to the control panel will need to be replaced and the motor should be inspected, prior to any electrical repairs taking place. The pool manager has coordinated with public works staff and the parks superintendent to remove the motor for inspection. Removal of the motor took place on Thursday November 10th, and the motor was driven to Sparks Electric Motor on Friday November 11th. Diagnosis of the Motor is pending, and the cost of the repairs are currently unknown, but were not budgeted for. During the off season several known plumbing repairs have taken place, the facility has been winterized and a budget analysis is underway in anticipation of needing to adopt an amended budget in the springtime.
